NMAS REVIEW

At the AGM the chair spoke to the NMAS Review. We are now in a position to provide you with an important update.

The main component of this review is a Survey that was circulated on the 14 February to our member organisations, and the broader ADR community, and is now closed.

The response was above expectations, and we thank those that took the time to complete it.

There was further communication that the Board had pre-approved allocation of 1 CPD point for those who complete the survey. It was necessary for those RMABs to apply to the MSB for approval for this credit. Written confirmation was sent to those who applied, and a reminder that after the closure, each person who completed the survey will be sent a certificate for 1 CPD point directly from Resolution Resources.

We are on track to receive draft recommendations for the update of the NMAS Standards by 30 June 2022.
